Teaser	If you submit an income tax return for the past calendar year, the tax offices can usually only issue tax assessments **from mid-March** of the following year.
Volltext	For income tax returns, the tax offices can usually only issue tax assessments **from mid-March** of the following year. The reason for this is as follows: Employers, insurance companies and other institutions have until the end of February to electronically transmit tax data such as wage tax certificates, pension notifications or contribution data for old-age provision (Riester/Rürup) and for health and long-term care insurance to the tax authorities. The centrally transmitted data must then be processed and made available to the tax authorities so that they can be taken into account when processing the tax return. The electronic transmission of the data takes place on the basis of legal regulations.
Erforderliche Unterlagen	The income tax return should be made using an electronic tax return (Mein ELSTER) or a paper form. For income tax returns, we recommend the electronic tax return with receipt retrieval (pre-filled tax return), see links.
