If you are no longer permanently separated from your spouse/partner, you are again entitled to the tax class combination III/IV, IV/IV or IV/IV with a factor.

Volltext

If you and your spouse or life partner resume the marital / civil partnership after a permanent separation, you are again entitled to the family-friendly tax classes III / V, IV / IV or IV / IV with factor.

The family-friendly tax bracket can then already be taken into account in the wage tax deduction procedure. It will be taken into account at the beginning of the month in which the separation ended.

If tax class II was taken into account for you and / or your permanently separated spouse / partner while living separately, this does not apply when the

Erforderliche Unterlagen	<p>Form 'Declaration on the resumption of the marriage/life partnership' with tax identification number and signature of both spouses/life partners.</p> <p>Note: If the application form is signed by both spouses/partners, only one spouse/partner needs to be present when applying in person.</p> <p>You also have the option of creating and sending the application via ELSTER.</p>
