Verfahrensablauf	The identification number (IdNr) will be sent to you automatically by letter from the BZSt after your birth or when you move to Germany from abroad for the first time, as soon as the registration authority has sent the required data to the BZSt.
Bearbeitungsdauer	It may take up to 4 weeks for your IdNo to be communicated. When registering for the first time in Germany or after birth, shipping can take 4-8 weeks. If it has not been sent after 3 months, it is also advisable to submit a written application to the BZSt, stating the required data.

Hinweise	The local tax offices cannot issue tax identification numbers and cannot influence the allocation process of the Federal Central Tax Office. The registration offices are responsible for changing the civil status data in the registration register (e.g. marriage, birth).

Kurztext	Tax identification number, notification (tax offices) The ID number: Receive (including children, since tax liability can arise from birth) for clear identification in the taxation process. You will be informed automatically by letter from the BZSt after your birth or when you first move to Germany from abroad as soon as the registration authority has sent the required data to the BZSt. Will replace the tax number in the future for the area of income tax. For a transitional period it is necessary that both numbers are used in parallel. Remains valid throughout your life and does not change when you move or get married. Is an 11-digit number and does not contain any information about you or the responsible tax office. Can be seen in the following of your documents, among others: income
