Teaser	You can have the care directive publicly certified.
Volltext	<p>With a care directive, you can specify who should take care of your affairs and to what extent if you are no longer able to do so yourself due to illness, disability or old age.</p> <p>A care directive comes into effect when the care court decides that you need a legal guardian. The court will try to take your wishes as set out in the care directive into account.</p> <p>To make your care directive legally valid, you should write it down and sign it, stating the place and date. You can also have the care directive officially certified by the responsible authority. Although this certification does not replace notarization in all cases, it does increase the acceptance of your signature.</p>

Hinweise	<p>With a care directive, you can determine in advance who should be responsible for you in the event of legal care. In the event that you are no longer able to manage your own affairs due to illness, disability or old age, you can determine in which areas (for example health matters, financial matters or right to determine your place of residence) you should be cared for and set out your wishes and ideas regarding your care and lifestyle.</p> <p>In complicated legal matters, involve a notary. If necessary, seek legal advice.</p> <p>In addition, hospital and nursing home social services often provide advice on care directives.</p> <p>The Federal Chamber of Notaries maintains a central pension register in which you can store all data (<a href="http://www.vorsorgeregister.de">www.vorsorgeregister.de</a>).</p>
