	 patient training for the chronically ill, rehabilitation sport and functional training, socio-medical aftercare measures for chronically ill or seriously ill children and young people.
	The services must be medically necessary and prescribed by a doctor.
Erforderliche Unterlagen	 Application for supplementary rehabilitation benefits Medical prescription or statement from the doctor treating you
Voraussetzungen	 You must be required to provide supplementary rehabilitation services in order to achieve or secure the goal of rehabilitation. Medical treatment must already have been provided or will still be provided by the health insurance company.
