Teaser	If you handle organic solvents in your company, you may have to report the system to the responsible authorities if you exceed an activity-related threshold.
Volltext	Plants that do not require a permit and in which certain amounts of organic solvents are handled must be reported to the competent authority before they are put into operation or in the event of significant changes. This applies to systems that are listed in Annex I of the 31st BImSchV and in which activities according to Annex II are carried out if the solvent consumption for the respective activities exceeds the threshold values specified in Annex I. The competent authority checks your notification and records the system in its system register.
