Teaser	Do you want to operate a low-frequency system or a DC system? Then, under certain conditions, you must report this to the responsible immission control authority.
Volltext	As the operator of a low-frequency system with a nominal voltage of 110 kV or more or a DC system, you are obliged to notify the responsible authority before commissioning or any significant change. The competent authority checks the notification and records the system in its system register.
Erforderliche Unterlagen	• Display with the relevant data for the system • site plan
Voraussetzungen	requirement is, that • the system is located on a plot of land in the area of a development plan or within a built-up district or on a plot of land with residential buildings in the outside area or crosses such plots of land, • the system or its significant change does not require a permit, plan approval or other official decision in which the interests of immission control are taken into account.
