Volltext	According to the Chemicals Climate Protection Ordinance, certificates of expertise are required for the personnel carrying out certain types of work. These certificates are issued after the test has been passed. In order to carry out such examinations and issue corresponding certificates, you need to be recognized as an examination and certification body. You apply for recognition as an examination and certification body to the responsible authority.
Erforderliche Unterlagen	With the application you submit information about the examiners you have commissioned, the examination procedure and the content of the certificates. If necessary, the competent authority may request further documents from you: • Training documents of future lecturers, • Contents of the course, • Schedule for the implementation of the course, • Examination regulations, • Procedural rules for issuing certificates of competence, • List of equipment intended for training, • Sample of an exam paper, • Questionnaire for the theoretical exam, • Sample certificate of competence, • Description of the practical exam, • Information on the spatial facilities of the training and further education facility
Voraussetzungen	 They are able to assess the suitability of technical or manual training. They carry out the tests impartially and independently. They plan and structure the exams in such a way that the specified minimum technical requirements are covered. They establish procedures for reporting and keep records of the individual and overall results of the audit. They ensure that the commissioned auditors are familiar with the relevant test methods and test

	documents and have the appropriate competence in the area to be tested. • They ensure that the devices, tools and materials required for the practical examinations are available.
Kosten	Fees apply. The amount of the fee depends on the time required.
Verfahrensablauf	 You submit a written or electronic application to the competent authority for recognition as an examination and certification body. The authority will examine your application. If necessary, the authority will request additional application documents from you. The authority decides on your application. You will receive a notification from the competent authority.

Frist	You need recognition as a testing and certification body before you carry out tests or issue certificates.

Hinweise	The testing and certification body carries out tests and issues certificates of expertise that are required for certain activities (according to the Chemicals Climate Protection Ordinance). These include in particular: • Leakage control, gas recovery, installation, repair, servicing, maintenance or decommissioning • from facilities containing fluorinated greenhouse gases Certification bodies can also act as examination bodies.
Rechtsbehelf	• Objection within one month after receipt of the decision.

	 Examination and certification body conducts examinations and issues certificates of expertise that are required for certain activities Leak control, gas recovery, installation, repair, maintenance, servicing or decommissioning of equipment containing fluorinated greenhouse gases and by companies that carry out these activities in connection with refrigeration systems, air conditioning systems or heat pumps for third parties persons carrying out the work require a certificate of competence Certificate of competency after passing the exam Tests impartial and independent Examinations meet the specified minimum technical requirements Examination and Certification Body establishes reporting procedures and keeps records of examination results The examination and certification body ensures that the examiners commissioned by it are instructed and competent The examination and certification body provides the necessary devices, tools and materials for the practical examinations
