Teaser	If you, as the operator of a landfill, are obliged to submit an emissions declaration, you can be exempted from the obligation to submit an emissions declaration under certain conditions.
Volltext	If you operate a landfill, you are obliged to submit an emissions declaration on a regular basis. If your landfill emits only a small amount of emissions, you can be exempted from the obligation to submit an emissions declaration. You can apply to the competent authority for exemption from submitting an emissions declaration for landfills.
Erforderliche Unterlagen	• written Application • Documentation required to show that your landfill site emits only low levels of emissions
Voraussetzungen	You will be exempted from the emission tax obligation if your landfill only emits a small amount of emissions.
Kosten	Fees apply. The responsible authority calculates the amount of the fees based on the time spent and on the basis of the environmental fee regulations.
Verfahrensablauf	You submit a written application for an exemption
