Teaser	You can apply for the subsequent certification of a death on a foreign seagoing vessel in a German death register at the competent German registry office.
Volltext	A death that occurred abroad can also be certified, i.e. entered, in a German death register upon your request. The so-called subsequent certification also applies to deaths on foreign seagoing vessels. Deaths on foreign seagoing vessels are deaths abroad with the special feature that the place of death is a foreign seagoing vessel. With the subsequent certification, an entry is made in a German death register in addition to the certification abroad, i.e. in addition to the entry in the death register of the country in which the death

Erforderliche Unterlagen	<p>For the information to be included in the death record, you must provide the necessary certificates or other documents that you have. In particular, the following documents are required: Your identity card/passport as the applicant Foreign death certificate of the deceased (if necessary with a translation and certification by the competent foreign authority (apostille) or legalization by the German mission abroad; it may be sufficient to submit a multilingual form) the marriage or civil partnership certificate of the deceased person's last marriage or civil partnership and/or proof of its dissolution, the birth certificate of the deceased, proof of the deceased person's last place of residence for naturalized persons, persons entitled to asylum, stateless persons, homeless foreigners and recognized foreign refugees: certificate of naturalization/ proof of special status</p>
Voraussetzungen	<p>The death occurred on a foreign seagoing vessel The death occurred during a sea voyage outside the seagoing vessel - but not on land or in a domestic port - and the deceased was taken on board a foreign seagoing vessel The deceased had held German citizenship at the time of death The deceased had the status of a stateless person, a homeless alien or a foreign refugee within the meaning of the Convention relating to the Status of Refugees who Ordinarily Resident in Germany are Eligible to Apply the parents, children, spouse and civil partner of the deceased any other person who can assert a legal interest in the certification against the registry office</p>

Verfahrensablauf	<p>You submit the application for subsequent certification of a death on a foreign seagoing vessel to the responsible German registry office. Contact the responsible German registry office in writing, by telephone or in person, describe your request and ask for the documents you need to submit. Submit the application for subsequent certification and enclose the required documents. The registry office will check your information and the evidence you have submitted</p>

Kurztext	<p>Subsequent certification of a death on a foreign seagoing vessel in a German death register. Under certain conditions, the application for subsequent certification can be submitted to the competent German registry office. Fees are charged by the registry office. The subsequent certification is a prerequisite for the issuance of a German death certificate. responsible: registry office in whose area of responsibility the foreign-born person has or last had their place of residence or has their usual place of residence. If the deceased person's last place of residence or habitual residence was in Germany, the registry office responsible for this location will certify the death. If there is no responsibility, the registry office certifies the civil status case in whose area of responsibility the applicant has his or her place of residence or last had or has their usual place of residence. If there is no responsibility afterwards, the registry office I in Berlin will certify the civil status case.</p>
