If you live in another federal state and want to fish in Hamburg, you also have to pay the fishing tax, even if you have already done so at your place of residence.

Kosten	The fishing tax for anglers is EUR 10.00 per calendar year.
Verfahrensablauf	Show up at the Hamburg Service or one of the recognized private issuing offices with your valid fishing license. If you do not live in Hamburg, you can only pay the fishing tax at one of the private issuing points. You can pay the tax there immediately.
