The competent authority checks the clearing based on your application documents for environmental compatibility and compatibility with other public interests. If necessary, the competent authority will involve other departments concerned for the assessment. You will be informed of the decision in writing. |
| Bearbeitungsdauer             | The processing time depends on the type and scope of the application.
