Teaser	If you want to discharge commercial wastewater into a private wastewater plant or sewer system, you usually need to apply for a permit in advance.
Volltext	As a rule, you need a permit to discharge commercial wastewater into private wastewater systems (for example in commercial and industrial parks). You must apply for approval from the relevant authority. You must have the permit before you start discharging the wastewater.
Erforderliche Unterlagen	• Completed application form • The documents specified in the application form
Voraussetzungen	You will be granted permission if the quality and quantity of the wastewater is suitable for being discharged into a private wastewater plant.

Verfahrensablauf	• You submit a written application to the responsible authority. With the application you submit further documents on the type and scope of your project. · • If necessary, the responsible authority will request further documents from you. • The responsible authority will examine your application and decide whether to approve it. • The decision of the responsible authority will be communicated to you in a written notice. • With the notice, you may be given requirements that you must implement. • You will receive a fee notice

	You pay the administration fees
Bearbeitungsdauer	You must expect a processing time of up to several months.
Frist	No. However, you must have approval before you begin the initiation process. You should therefore submit the application well in advance of the intended start of your project.
