Teaser	If you are moving onto an inland vessel that is registered for a domestic ship register, you must register. If you are the captain or crew member of a seagoing vessel, the shipowner will register you at the beginning of your employment, contract or apprenticeship.
Volltext	If you are embarking on an inland vessel that is registered for a domestic ship register, you must register at the location of the ship's home port. If you sail on a seagoing vessel that is authorized to fly

	the federal flag, the shipowner will register you at the beginning of the employment, hiring or training relationship. To do this, you must provide the shipowner with the necessary information. In both cases, there is no obligation to register if you are registered for an apartment in Germany.
Erforderliche Unterlagen	• Confirmation from the landlord • ID card or passport
Voraussetzungen	• The inland waterway vessel on which you register must be registered for a domestic ship register. • The seagoing vessel registered by the shipowner must be entitled to fly the federal flag.
Kosten	• The fees are 12 EUR • per adult, or • per person under the age of 18 auditioning alone.
Verfahrensablauf	• You make an appointment at the customer center - department for population data of the Hamburg-Mitte district office • You appear in person at the customer center - department for resident data of the Hamburg-Mitte district office or be represented by a person with power of attorney. • You fill out the registration form and sign it (except in the case of an automated registration form). • You submit all the required documents. • Finally, you will receive an official confirmation of registration from the registration office.
Bearbeitungsdauer	Registration takes about 12 minutes.
Frist	You must register with the registration office within two weeks of moving in. Late registrations can be punished with a fine.

Hinweise	• For inland vessels, the regulations on the general obligation to report apply. • Registration is only possible in the customer center in Hamburg-Mitte.

Kurztext	• Residence registration for bargees and seafarers • Anyone moving onto an inland waterway vessel that is entered in a domestic ship register must register with the registration office of the place where the ship's home port is located. • On a seagoing vessel that is entitled to fly the federal flag, the shipowner registers the person at his registered office. You can also register and de-register with another registration authority or with the water police, who will forward the data to the responsible registration authority. • Responsible: Customer Center - Department of Population Data Hamburg-Mitte
