Volltext	<p>If you are allowed to handle explosive substances in your company or place them on the market, you must appoint a responsible person in writing.</p> <p>You must immediately notify the responsible authority of the name, address and date of birth of the responsible person appointed in writing.</p> <p>You must also notify the relevant authority if the appointment of a responsible person expires.</p>

A certificate of competence is a permit for working with explosives.</li> </ul> <p>The responsible persons to be considered are:</p> <ul style="list-style-type: none"> <li>• Supervisors</li> <li>• Head of an operations department</li> <li>• Authorized explosives</li> <li>• Foremen and foremen</li> <li>• Technical supervisory staff in explosive ordnance</li> </ul>
