You must immediately notify the responsible authority of the name, address and date of birth of the responsible person appointed in writing. You must also notify the relevant authority if the appointment of a responsible person expires.

Voraussetzungen	 The person appointed in writing must be in possession of a valid official certificate of competence. A certificate of competence is a permit for working with explosives.
