Teaser	Has someone in your company or building been seriously injured or even died while using certain work equipment? Then you have to show this.
Volltext	<p>If an accident occurs during the use of work equipment and someone is seriously injured or killed, you as the employer must report this to the responsible authority.</p> <p>These specific work equipment includes systems that require monitoring such as,</p> <ul style="list-style-type: none"> <li>• Cranes</li> <li>• LPG systems</li> <li>• Mechanical equipment for event technology</li> <li>• Elevator systems</li> <li>• Printing systems</li> <li>• Systems in potentially explosive areas</li> </ul>
Erforderliche Unterlagen	<p>Informal notification with the following information:</p> <ul style="list-style-type: none"> <li>• Company address</li> <li>• Address of the business premises or the construction or assembly site at the event location</li> <li>• Date of event</li> <li>• Type of event e.g. explosion, media leak, crash</li> <li>• Number of injured persons, number of killed</li> </ul>

	<p>persons</p> <ul style="list-style-type: none"> <li>• Equipment involved</li> <li>• included approved monitoring body (for systems requiring monitoring according to Annex 2 of the Ordinance on Industrial Safety)</li> <li>• involved body for determining the cause (for work equipment according to Annex 3 of the Industrial Safety Ordinance)</li> <li>• Brief description of the event and the damage that occurred (including photos and videos) measures already taken by the employer</li> </ul> <p>The competent authority may also request the following information from you:</p> <ul style="list-style-type: none"> <li>• Risk assessment</li> <li>• Proof that a qualified person has prepared the risk assessment</li> <li>• Information about the responsible persons</li> <li>• Information on protective measures taken</li> <li>• Evidence of regular training of employees</li> <li>• Operating instructions</li> </ul>
Voraussetzungen	<p>You are an employer...</p> <p>The following tools are involved:</p> <ul style="list-style-type: none"> <li>• Elevator systems</li> <li>• Printing systems</li> <li>• Systems in potentially explosive areas</li> <li>• Cranes</li> <li>• LPG systems</li> <li>• Mechanical equipment for event technology</li> </ul>
Kosten	There are no costs involved.
Verfahrensablauf	<ul style="list-style-type: none"> <li>• You shall immediately submit the report of the event in writing or by email to the competent authority with all necessary information.</li> <li>• The ad is being reviewed.</li> <li>• The competent authority will inform you whether further documentation (e.g. an assessment by an approved inspection body) is required.</li> <li>• The accident will be investigated if necessary.</li> </ul>
Bearbeitungsdauer	The competent authority will report immediately.
Frist	You must report the accident immediately.
