Volltext	Damage to certain systems has occurred in your company or building due to the failure of components or safety equipment. You must report this to the responsible authority. These specific work equipment includes systems that require monitoring, cranes, liquid gas systems or mechanical equipment used in event technology.
Erforderliche Unterlagen	 Informal notification with the following information: Company address Address of the business premises or the construction or assembly site at the event location Date of event Type of event e.g. explosion, media leak, crash Number of injured persons, number of killed persons Equipment involved included approved monitoring body (for systems requiring monitoring according to Annex 2 of the Ordinance on Industrial Safety) involved body for determining the cause (for work

	The occupational safety authority may also request the following information from you: Risk assessment Proof that the risk assessment was prepared by a qualified person Information on responsible persons Information on protective measures taken Operating instructions
Voraussetzungen	 You are an employer. The following tools are involved: Elevator systems Printing systems Systems in potentially explosive areas Cranes LPG systems Mechanical equipment for event technology It must be a case of damage in which components or safety devices have failed.
Kosten	There are no fees or expenses.
Verfahrensablauf	 Immediately submit the report of the event to the competent authority in writing or by email, along with all the necessary information. The ad is being reviewed. The competent authority will inform you whether further documentation (e.g. an assessment by an approved inspection body) is required. The accident will be investigated if necessary.
Bearbeitungsdauer	The competent authority will report immediately.
Frist	The damage must be reported immediately.
