Handlungsgrundlage	<p>Ordinance on the blocking time in the restaurant and entertainment industry (blocking time ordinance) <https://www.landesrecht-hamburg.de/bsha/document/jlr-SperrZeitVHA2003rahmen></p> <p>Restaurant Act (GastG) <https://www.gesetze-im-internet.de/gastg/_18.html></p>
Teaser	There is a closing time for the restaurants and events, by which time operations must be stopped. You can request a reduction in the blocking period.
Volltext	<p>In some countries there is a restricted period for restaurants and events. At this time, operations must be suspended. You can request a reduction in the blocking period. The legal requirements are regulated differently depending on the country.</p> <p>In the Free and Hanseatic City of Hamburg, restaurants and bars are closed from Sunday to Thursday night from 5:00 a.m. to 6:00 a.m. During this time, the catering establishments have to close.</p> <p>For music performances, shows and other entertaining events, the daily closing time is from midnight to 6 a.m.</p> <p>These closing times do not apply on New Year's Eve or on May 1st and 2nd. If your company is part of a folk festival or a market, this blocking period does not apply to you either.</p> <p>The closure times are intended to protect the general public from constant noise pollution.</p>

	A shortening of the blocking period is possible on request.
Erforderliche Unterlagen	Informal justification in text form regarding the existence of a public need.
Voraussetzungen	<p>The existence of a public need or special local conditions must be demonstrated.</p> <p>However, there must be a "public need" or special local conditions for the blocking period to be shortened. A restriction would therefore have to be in the public interest, which corresponds to the "public need" of your application. This interest must be stated in detail in the application.</p>
Kosten	Cost amount (fixed): EUR 45.00
Verfahrensablauf	<p>If you want to apply for a reduction in the blocking time, then</p> <ul style="list-style-type: none"> • submit an application for a reduction in the blocking period online or in writing to the responsible authority as early as possible. • explain in detail why you see a "public need" to reduce the lockdown period. This is often justified by the event that you want to continue. • You will receive an approval or a notice of rejection of the application.

Sachverhalt

- As a rule, a public need must be justified for the application.
- General closing time in Hamburg between 5 a.m. and 6 a.m.
- There are no closed times for taverns and restaurants on the following days:
 - In the nights leading up to Saturday and Sunday
 - On the nights of January 1st and May 1st and 2nd
- Closing time for music performances, shows, entertaining performances and other outdoor amusements from midnight to 6 a.m.
- There is no blocking period for companies and events at fixed folk festivals and markets.
- A shortening of the blocking period is possible on request.
- The applicant must demonstrate a "public need" or special local conditions.
