Teaser	If you are from the EU/EEA/Switzerland and have acquired a qualification as a veterinarian, you will find the relevant requirements for the recognition of your training here.
Volltext	In order to be able to work as a veterinarian in Germany without restrictions, you need a license to practice medicine.
Erforderliche Unterlagen	 Proof of identity (copy of identity card or passport) a copy of your training certificate List of subjects and hours of training that you have completed Evidence of your professional practice as a veterinarian Criminal record extract or certificate of good conduct from your country of origin as proof of your worthiness and reliability (this proof must not be more than 3 months old when you apply.) Evidence of the content of your training: Medical certificate of your health suitability (This

	 certificate must not be more than 3 months old when you apply. The proof can be from an authority in your country of training.) Declaration that you have not yet applied for a license to practice medicine in Germany The competent authority will inform you which documents you have to submit in the original or as a copy. If your documents are not in German, you must submit German translations of your documents. The translations must be made by translators who are publicly appointed or authorized. The competent authority will inform you about which documents you have to submit. Important documents are often:
Voraussetzungen	 You have a professional qualification as a veterinarian from the EU, the EEA or Switzerland. You are physically fit to work as a veterinarian. You are reliable and worthy of working as a veterinarian and have no criminal record. You have the German language skills required for the job. These are general language skills at level B2 according to the Common European Framework of Reference for Languages.
Kosten	The granting of the approval is subject to a fee and is charged according to the fee schedule for public consumer protection (GebOöV). The competent authority will inform you about the costs.
Verfahrensablauf	
Bearbeitungsdauer	The authority for justice and consumer protection will confirm after a maximum of one month that your application and your documents have been received. The competent authority will inform you if documents are missing.

Kurztext	 In Germany, a state license is required to work as a veterinarian. With a license to practice medicine you can work as a veterinarian without restrictions. Approbation can also be obtained in Germany with a professional qualification from the European Union (EU), the European Economic Area (EEA) or Switzerland. It is important where and when you acquired your professional qualification.
