Erforderliche Unterlagen	• Application according to § 4 AGeV in Appendix 1 of the AGeV • The application must be accompanied by an examination result and a sample of three bottles.
Voraussetzungen	• They want to circulate German brandy or brandy.
Kosten	• up to 5,000 l: 105.00 euros • over 5,000 l: 190.00 euros
Verfahrensablauf	• You submit the application to the authority for justice and consumer protection a sample of three bottles of the beverage to be tested or an examination result from an examination facility approved by the competent body • the authority for justice and consumer protection examines the application, the submitted samples and the test results • You will receive notification of the result of the test and, if applicable, the test number

Hinweise	• At least one bottle of each sample must be retained for a period of two years after the test report has been issued. • A copy of the test results must be retained by the institution that carried out the test for five years.

	• If the authority for justice and consumer protection does not carry out the investigation itself, the findings of an investigation can also be submitted to an investigation facility approved by the competent body. • Several test numbers can also be issued on request. • A copy of the test results must be kept by the applicant for five years.
