Teaser	Under certain conditions, you can obtain an operating license for a second pharmacy.
Volltext	If there is an emergency in the supply of medicines because there are not enough pharmacies to supply the population, you as a pharmacy owner can apply for a permit to operate a branch pharmacy. These branch pharmacies have lower spatial requirements than normal pharmacies, but these are set by law. Branch pharmacies must be managed by a person with appropriate authorization. You may only operate one branch pharmacy.

	the European Union or in another contracting state to the Agreement on the European Economic Area or in a contracting state to which Germany and the European Union have contractually granted a corresponding legal right • Proof that you have the required operating premises
Voraussetzungen	• There is an emergency in the supply of medicines. • They have the rooms required by law. • You are the owner of a pharmacy near the premises of the planned branch pharmacy.
Kosten	Fees apply. The amount of the fees depends on the processing effort.
Verfahrensablauf	• You submit your application with the required documents to the responsible authority. • The responsible authority will examine your application and documents. If necessary, it will request further documents or information from you. • The responsible authority inspects the premises and checks the requirements. • The responsible authority will decide on your application. • You will receive a notification.
Bearbeitungsdauer	Processing usually takes 4 to 8 weeks.
Frist	Submit the application at least 2 months before the planned opening of the branch pharmacy. All required documents must be submitted no later than 2 weeks before the opening. You will receive permission to operate the branch pharmacy for a period of 5 years. You can then reapply for permission.
