Volltext	<p>The work of a health and nursing professional is regulated in Germany.</p> <p>This means that in order to work as a health and nursing professional in Germany, you must apply for a state permit. With this permit, you can use the job title “health and nursing professional” and work in the profession.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• State examination certificate or notice of equivalence of the foreign professional qualification               <ul style="list-style-type: none"> <li>• Proof of reliability: confirmation that you have not been guilty of any conduct that would make you unreliable to exercise your profession (for example, by submitting an official certificate of good conduct that is no more than 3 months old)</li> <li>• Medical certificate stating that you are suitable to perform the profession</li> <li>• Confirmation that you have the knowledge of the German language required to perform your professional activity</li> </ul> </li> </ul>
