Volltext	After you have successfully completed your state examination as a speech therapist, you need a professional license in the form of a professional certificate in order to be allowed to work in this profession.
Erforderliche Unterlagen	Application (available online) Medical certificate not older than 3 months (available online) official certificate of good conduct, not older than 3 months
Voraussetzungen	You have successfully completed your state examination in Hamburg. You have not been guilty of conduct that renders you unreliable for the exercise of your profession. You are not unsuitable for the exercise of the profession in terms of health. You have the knowledge of the German language required for the exercise of your professional activity.
Kosten	Depending on the effort between EUR 40 and EUR 80.
Verfahrensablauf	With the admission to the state examination, the examinees receive all relevant information and templates that they need to apply for the professional license.
