Voraussetzungen	• You have successfully completed your state examination in Hamburg. • You have not been guilty of conduct that renders you unreliable for the exercise of your profession. • You are not unsuitable for the exercise of the profession in terms of health. • You have the knowledge of the German language required for the exercise of your professional activity.
