Volltext	As the person responsible for radiation protection, you inform the competent authority who you have appointed as your radiation protection officer. You must also inform the responsible authority of any change in the duties or powers of a radiation protection officer or of his or her departure.
Erforderliche Unterlagen	Proof of current expertise in radiation protection If applicable, proof of activities within the scope of further permits with this or other operators, stating the operator and to what extent. For doctors, proof of license to practice medicine
Voraussetzungen	There are no facts that give rise to concerns about their reliability. Existence of the necessary expertise in radiation protection, and in the case of doctors, approval. As a doctor, you have a license to practice medicine.

Verfahrensablauf	<p>You fill out the relevant form completely and send it, together with the required documents, to the responsible authority. In the appointment notice, please state the following regarding the radiation protection officer: Area of responsibility internal decision-making area the powers necessary to carry out the tasks Please send a copy of your notification to your works council or staff council. The responsible authority will examine your notification and your documents. If necessary, she will request further documents or information from you. The responsible authority will check your information to see if it meets the requirements. The responsible authority will send you a notification confirmation.</p>
Bearbeitungsdauer	<p>The processing time is usually 2 to 4 weeks. If additional documents have to be requested, the process may take longer.</p>
