Teaser	Under certain conditions, a foundation will be dissolved ex officio.
Volltext	If a foundation has to be dissolved but the responsible body does not decide on the dissolution in a timely manner, the foundation will be dissolved ex officio.
Erforderliche Unterlagen	No
Voraussetzungen	If the responsible body of the foundation does not decide on the dissolution of the foundation in a timely manner, the foundation will be dissolved ex officio. If the foundation endangers the general welfare and this threat is not eliminated in another way, the foundation will be terminated ex officio. If the administrative headquarters of the foundation was established abroad and the authority cannot achieve the transfer of the administrative headquarters domestically within a reasonable time, the foundation will be dissolved ex officio.
Kosten	According to the Hamburg Fees Act, fees are charged for the cancellation of a foundation, which depend on the effort involved.
Verfahrensablauf	This is not an application service. The responsible authority checks the requirements based on the available documents and information. You can report any information about possible behavior that is harmful to the common good to the responsible authority.
