Teaser	If you as a company want to treat animal by-products after their collection (sorting, cutting, cooling, freezing, salting, removing skins, fur or specific risk material), you must be authorized for this activity by the competent authority.
Volltext	If you want to sort, cut up, cool, freeze or salt animal by-products commercially or remove their skins, fur or specific risk material, you need approval from the responsible authority.
Erforderliche Unterlagen	Application Extract from the commercial register Plans of the facilities/operations that will be approved For certain systems or operations, additional documents are required, which will be communicated during the application process.
Voraussetzungen	Your company is registered as a business in the area of the Free and Hanseatic City of Hamburg. Further

	requirements may arise depending on the type of activity and must be checked on a case-by-case basis.
Kosten	The amount of the fee depends on the effort required to process it.
Verfahrensablauf	Submit an application for authorization to treat animal carcasses and animal by-products with all necessary documents to the responsible body. The responsible office will examine your application and your documents. If necessary, the responsible authority may request further documents or information from you. The responsible authority will decide on your application. You will receive a notice and an invoice for fees. You pay the fee bill. You may begin treating the animal carcasses or animal by-products in accordance with the notice.
Bearbeitungsdauer	The processing time varies depending on the inspection effort and the type of activity.
Frist	You need approval before you can start the activities.
