Voraussetzungen	Business registration in the area of the FHH Other requirements vary depending on the type of activity and must be checked on a case-by-case basis.
Kosten	The amount of the fee depends on the complexity of the processing.
Verfahrensablauf	Application to the competent authority Document review Registration of the company including assignment of a registration number
