<b>Teaser</b>	If you want to slaughter animals without anesthesia, you need an animal welfare permit.
<b>Volltext</b>	If you want to slaughter or slaughter animals without stunning, you must apply for an exemption from the responsible authority.
<b>Erforderliche Unterlagen</b>	<ul style="list-style-type: none"> <li>• Name and address of the applicant</li> <li>• Name and address as well as information on the expertise of the person carrying out the slaughter</li> <li>• Information about the group of people for whom the slaughter is to take place (e.g. religious communities, individuals)</li> <li>• Description of the religious regulations for slaughter</li> <li>• Type and number of animals to be slaughtered</li> <li>• Slaughtering period</li> <li>• Place of slaughter</li> <li>• Equipment used for slaughter</li> <li>• whereabouts of the meat</li> <li>• Declaration that the meat will only be given to people who must adhere to mandatory religious regulations regarding slaughter</li> <li>• Description of the religiously prescribed slaughtering process</li> <li>• Information about how animal welfare regulations are adhered to during the slaughtering process</li> </ul> <p>The written application for slaughter must contain the following information:</p>
<b>Voraussetzungen</b>	<ul style="list-style-type: none"> <li>• this is absolutely necessary to comply with religious rites or dietary regulations,</li> <li>• the person carrying out the work has the necessary</li> </ul>

	<p>expertise and</p> <ul style="list-style-type: none"> <li>• the slaughterhouse complies with legal requirements.</li> </ul> <p>You may only slaughter animals without anesthesia if:</p>
Kosten	The fees are calculated according to the actual effort.
Verfahrensablauf	<ul style="list-style-type: none"> <li>• Submit a written application to the responsible authority and submit it including all required documents.</li> <li>• The responsible office will examine your application and your documents and, if necessary, request further documents or information from you.</li> <li>• The responsible authority will decide on your application.</li> <li>• You will receive a notification from the responsible authority.</li> <li>• You will receive the fee notice.</li> <li>• You pay the fees.</li> </ul>
Bearbeitungsdauer	The processing time depends on the testing effort and is at least 4 weeks.
Frist	Submit the application before you start slaughtering.
