Teaser	If you would like to set up a counseling center for pregnancy conflict counseling, you must apply to the Health Office of the Social Welfare Authority.
Volltext	Pregnancy conflict counseling centers advise every woman and every man on questions of sex education, contraception and family planning as well as on all questions to do with pregnancy. If you would like to set up a pregnancy conflict counseling center, you must submit an application and meet certain requirements.

Erforderliche Unterlagen	• Application • Evidence of the required qualifications of the counseling staff at the counseling center You will receive the application on request, but it will also be available as a download in the near future.
Voraussetzungen	To be recognized as a counseling center for pregnancy conflict counseling, you must meet the following requirements: • You must assure that there are sufficiently qualified personnel available to provide professional advice. • You must ensure that other specialists can be brought in at short notice to carry out the advice • You must work with all agencies that provide public and private assistance to mothers and children • They must not be affiliated with any body in which abortions are performed, either organizationally or economically.

Verfahrensablauf	In order to be recognized as a counseling center for pregnancy conflict counseling, you must submit an application. To do this, you can contact a member of staff at the office responsible for you by telephone. There you will receive all information about the necessary application documents and the legal provisions as well as the appropriate forms for your application. The application must be legally signed by the person who can be held liable for the counseling center. Submit the complete application with the attachments to the Department of Bioethics and Law of the Public Health Office. After the examination has been completed by the application office responsible for you, you will receive a notice of recognition. The notice contains instructions with information on what you can do if you do not agree with the notice.

Kurztext

- State recognition of a counseling center according to the Pregnancy Conflict Act (SchKG)
 - State recognition as a counseling center is mandatory in order to be able to provide pregnancy conflict counseling
 - The establishment of a pregnancy conflict counseling center can be applied for by independent organizations and local authorities
 - Doctors can also be recognized as a counseling center
 - For recognition, certain requirements must be met, which must be proven when applying
 - Public funding from a recognized counseling center is granted under certain conditions
 - Qualified staff for the counseling center must be available and can be selected by yourself
 - The staff must meet certain qualification requirements
