Teaser	Do you have a disability or are you threatened by a disability? Or are you looking after a child or a person with disabilities? The diverse services of integration assistance are intended to help enable participation in all areas of social life.
Volltext	The services of integration assistance are intended to enable people with disabilities to participate comprehensively in all areas of social life. The services of the integration assistance are divided into 4 service groups: Medical rehabilitation services Benefits for participation in education Benefits for participation in working life Benefits for social participation Among other things, the benefits can help you to cope with the tasks of everyday life. These include, for example: Reside finance housekeeping recreation Promotion of private contacts and hobbies Official appointments (preparation and support), unless the task of a legal supervisor mobility parenting Support at school, university or for further training at work support in daycare aids promoting understanding Work The services are individually designed. They are subordinate to the services of other social service and rehabilitation providers (e.g. health insurance, pension insurance providers). The responsible institution for integration assistance bears the costs for the services. Your income or assets can be taken into account.

Erforderliche Unterlagen	informal written request completed checklist (see links) When applying for integration assistance in a special form of housing (formerly: inpatient facility), it may be necessary to apply for basic security. (see links) Medical documents (e.g. certificates, reports, etc.) Completed and signed release from non-disclosure (see links)
Voraussetzungen	You can receive integration assistance if you have a disability or You are threatened by a disability and As a result, you are significantly restricted in your daily life. You can also apply for integration assistance for people who represent you in the context of legal care, guardianship, or as authorized representatives or custodians.

Verfahrensablauf	You can apply for integration assistance from the institution responsible for you. You should contact the integration assistance provider responsible for you. You will be advised there or you can submit an informal application straight away. The competent authority may ask you to fill out a form and submit additional documents. The authority carries out a participation procedure, an overall plan procedure or both procedures in order to determine your individual need for integration assistance services and possible other participation services. You can request that someone you trust be involved in the overall plan process. When all the documents are available, the competent authority will check whether and which benefits you will receive based on your information and the assessment of your needs. This also includes checking whether and to what extent your income and assets are taken into account. After your application.
Bearbeitungsdauer	The processing time of your application depends on various factors. Please contact your responsible institution for integration assistance, which can provide you with more detailed information on the duration of the process. However, the authority to which you submitted your application must determine within 2 weeks of receipt of the application whether it is responsible for your application. If the authority is not

	responsible, it will immediately forward your application to the responsible body. You will be informed of the forwarding. If the authority does not pass on your application, it must determine and provide your need for support as quickly as possible. If an expert opinion is necessary to determine your needs, the authority must make a decision within 2 weeks as soon as the expert opinion is available to the authority. If the authority does not have to obtain an expert opinion, it will make a decision within 3 weeks after your application has been received.
Frist	The authority to which the application is submitted must determine within two weeks of receipt of the application whether it is responsible for the application. If the authority is not responsible, it forwards the application immediately.

Rechtsbehelf	Objections can be raised against the decisions of the competent integration assistance provider within one month of notification. After the objection procedure has been completed by means of an objection notice, a complaint can be filed with the competent social court

Kurztext	Integration assistance for people with disabilities People who are significantly restricted by a disability or who are significantly threatened by a disability can receive support The integration assistance services are intended to improve the living conditions of people with (threatening) significant disabilities and enable comprehensive participation in life in society. The scope of the benefits depends on the individual needs of the beneficiaries. Integration assistance services are divided into 4 groups: Medical rehabilitation services Benefits for participation in working life Benefits for participation in education Benefits for social participation The services are determined according to individual needs. The providers of integration assistance and the advisory services of the supplementary independent participation advice (EUTB) offer opportunities for advice.
