Teaser	Would you like to work as a dietician in Germany? Then you need a state permit. You can have your foreign professional qualification recognised.
Volltext	In order to work as a dietitian in Germany, you need a professional permit. For this purpose, the equivalence of your foreign training with the German training will be checked. If there is equivalence, you can get a work permit if the requirements are met. If there is no equivalence, you must first complete an adjustment measure (knowledge test/adjustment course) before you can receive a work permit.
Erforderliche Unterlagen	<ul> <li>Application (available online)</li> <li>Documents according to leaflet (available online)</li> <li>Proof of language proficiency B2/ technical language test (see leaflet)</li> <li>Medical certificate (available online)</li> <li>Official certificate of good conduct according to § 30 Para. 5 BZRG</li> </ul>
Voraussetzungen	<ul> <li>You have successfully completed training as a dietician outside of the European Union (EU), the European Economic Area (EEA) or Switzerland and are entitled to work independently as a dietitian there.</li> <li>You want to work as a dietician in Germany.</li> <li>Personal Suitability: You are reliable to work as a dietician and have no criminal record.</li> <li>Medical suitability: You can work mentally and physically as a dietitian or dietician.</li> <li>You have German language skills at the required language level. This is usually language level B2 according to the Common European Framework of Reference for Languages (CEFR).</li> </ul>
Kosten	at least EUR 225, depending on the effort up to EUR 600 plus EUR 42 for the certificate
Verfahrensablauf	**application** You compile your documents using the leaflet that you can find on our website or that you have received from us. Submit the documents together with the application in the required form.

	The competent authority will then check whether you meet all the requirements. An important prerequisite is the equivalence of your professional qualification. The competent authority compares your professional qualification from abroad with the German professional qualification as a dietician. The professional qualification is equivalent if there are no significant differences between your foreign professional qualification and the German professional qualification.
	**Possible results of the test** If there is equivalence, submit proof of your health, language and personal suitability (instruction sheet).
	If there is no equivalence, you will complete an adjustment measure in the form of a knowledge test or an adjustment course. You will receive further information from us on this.

Kurztext	<ul> <li>Dietician with training from a third country, recognizing foreign professional qualifications.</li> <li>In Germany, you need a state permit to work as a dietician.</li> <li>With the permit, you can officially call yourself a "dietician" and work in the profession.</li> <li>You can also obtain a state permit in Germany with a professional qualification from a country outside the European Union (EU), the European Economic Area (EEA) or Switzerland.</li> </ul>
