Teaser	<p>Would you like to work as a speech therapist in Germany? Then you need a state permit. You can have your foreign professional qualification recognised.</p>
Volltext	<p>In order to be allowed to work as a speech therapist in Germany, you need a professional permit. For this purpose, the equivalence of your foreign training with the German training will be checked. If there is equivalence, you can get a work permit if the requirements are met. If there is no equivalence, you must first complete an adjustment measure (knowledge test/adjustment course) before you can receive a work permit.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> • Application (available online) • Documents according to information sheet (available online) • Language certificate C2 / specialist language test (see information sheet) • medical certificate (available online) • Official certificate of good conduct according to Section 30 Para. 5 BZRG
Voraussetzungen	<ul style="list-style-type: none"> • You have successfully completed training as a speech therapist outside of the European Union (EU), the European Economic Area (EEA) or Switzerland and are entitled to work independently as a speech therapist there. • You want to work as a speech therapist in Germany. • Personal suitability: You are reliable to work as a speech therapist and have no criminal record. • Medical suitability: You can work mentally and physically as a speech therapist. • You have German language skills at the required language level. This is usually language level B2 according to the Common European Framework of Reference for Languages (CEFR).
Kosten	<p>at least EUR 225, depending on the effort up to EUR 600 plus EUR 42 for the certificate</p>

Verfahrensablauf	<p>**application**</p> <p>You compile your documents using the leaflet that you can find on our website or that you have received from us. Submit the documents together with the application in the required form.</p> <p>**equivalence test**</p> <p>The competent authority will then check whether you meet all the requirements. An important prerequisite is the equivalence of your professional qualification. The competent authority compares your professional qualification from abroad with the German professional qualification as a speech therapist. The professional qualification is equivalent if there are no significant differences between your foreign professional qualification and the German professional qualification.</p> <p>**Possible results of the test**</p> <p>If there is equivalence, submit proof of your health, language and personal suitability (instruction sheet).</p> <p>If there is no equivalence, you will complete an adjustment measure in the form of a knowledge test or an adjustment course. You will receive further information from us on this.</p>
