Teaser	<p>Would you like to work as a masseuse and medical lifeguard in Germany? Then you need a state permit. You can have your foreign professional qualification recognised.</p>
Volltext	<p>In order to be allowed to work as a masseuse and medical pool attendant in Germany, you need a professional permit. For this purpose, the equivalence of your foreign training with the German training will be checked. If there is equivalence, you can get a work permit if the requirements are met. If there is no equivalence, you must first complete an adjustment measure (aptitude test/adjustment course) before you can receive a work permit.</p>

Voraussetzungen	<ul style="list-style-type: none"> <li>• You have successfully completed training as a masseuse and medical pool attendant in the European Union (EU), the European Economic Area (EEA) or Switzerland and are entitled to work there as a self-employed masseuse and medical pool attendant to work.</li> <li>• You want to work in Germany as a masseuse and medical lifeguard.</li> <li>• Personal Suitability: You are reliable to work as a massage therapist and medical lifeguard and have no criminal record.</li> <li>• Medical suitability: You can work mentally and physically as a masseuse and medical pool attendant</li> </ul>

	<p>or masseur and medical pool attendant.</p> <ul style="list-style-type: none"> <li>You have German language skills at the required language level. This is usually language level B2 according to the Common European Framework of Reference for Languages (CEFR).</li> </ul>
Kosten	at least EUR 225, depending on the effort up to EUR 600 plus EUR 42 for the certificate
Verfahrensablauf	<p><b>**application**</b></p> <p>You compile your documents using the leaflet that you can find on our website or that you have received from us. Submit the documents together with the application in the required form.</p> <p><b>**equivalence test**</b></p> <p>The competent authority will then check whether you meet all the requirements. An important prerequisite is the equivalence of your professional qualification. The competent body compares your professional qualifications from abroad with the German professional qualifications as a masseuse and medical pool attendant. The professional qualification is equivalent if there are no significant differences between your foreign professional qualification and the German professional qualification.</p> <p><b>**Possible results of the test**</b></p> <p>If there is equivalence, submit proof of your health, language and personal suitability (instruction sheet).</p> <p>If there is no equivalence, you will complete an adjustment measure in the form of an aptitude test or an adjustment course. You will receive further information from us on this.</p>

Kurztext	<ul style="list-style-type: none"> <li>• Masseuse and medical pool attendant with training from EU/EEA/Switzerland, foreign professional qualifications recognized.</li> <li>• In Germany, you need a state permit to work as a masseuse and medical pool attendant.</li> <li>• With the permit, you can officially call yourself a masseuse and medical pool attendant and work in the profession.</li> <li>• You can also get a state permit in Germany with a professional qualification from the European Union (EU), the European Economic Area (EEA) or Switzerland.</li> </ul>
