Teaser Would you like to work as an emergency paramedic in Germany? Then you need a state permit. You can have your foreign professional qualification recognised.

Volltext In order to be allowed to work as an emergency paramedic in Germany, you need a professional permit. For this purpose, the equivalence of your foreign training with the German training will be

	checked. If there is equivalence, you can get a work permit if the requirements are met. If there is no equivalence, you must first complete an adjustment measure (knowledge test/adjustment course) before you can receive a work permit.

Voraussetzungen	<ul style="list-style-type: none"> <li>• You have successfully completed training as an emergency paramedic outside of the European Union (EU), the European Economic Area (EEA) or Switzerland and are entitled to work independently as an emergency paramedic there.</li> <li>• You want to work as an emergency paramedic in Germany.</li> <li>• Personal Aptitude: You are reliable to work as an EMT and have no criminal record.</li> <li>• Medical suitability: You can work mentally and physically as an emergency paramedic.</li> <li>• You have German language skills at the required language level. This is usually language level B2 according to the Common European Framework of Reference for Languages (CEFR).</li> </ul>
