Teaser	If you as a private individual want to handle explosive substances, you need an official permit.
Volltext	If you want to handle explosive substances in a non-commercial area, you need a permit. The competent authority may impose additional conditions to ensure that this does not pose a danger or nuisance to others.
Erforderliche Unterlagen	 Valid identity card or passport Proof of specialist knowledge or proven competent person (holder of a certificate of competence) Proof of need (does not apply to permission to handle pyrotechnic objects) Proof of liability insurance when handling category F3 and F4 fireworks Description of the intended storage (e.g. technical documentation, photographic evidence, storage plan) To check the reliability of people from abroad: You need a certificate in a certified translation from the responsible judicial or administrative authority in your home country or country of origin about certain facts that are important for assessing your reliability (e.g. extract from the criminal record).

	 You have the necessary specialist knowledge. You can prove your specialist knowledge with a certificate. The certificate confirms your successful participation in a state or state-recognized training course. You are reliable. You have the necessary reliability if you have previously behaved lawfully and have no criminal record. You are personally suitable. There are no restrictions, such as mental or physical health or drug or alcohol addiction. You can demonstrate a need. They have suitable rooms or storage facilities for storage.
Kosten	Fees apply. The amount of the fees depends on the processing effort. They are calculated based on the fee schedule.
Verfahrensablauf	 You fill out the application form completely and send it to the responsible office. Alternatively, you can submit the application online. If further information or documents are required for processing, the responsible authority will contact you. The responsible authority will decide on your application. You will receive a notification. You will receive the fee notice.
Bearbeitungsdauer	The processing time is usually 4 weeks.
Frist	You need permission before you can purchase and handle explosive substances. The responsible department will inform you of any special deadlines for subsequent submissions or feedback.
