Volltext	You are obliged to inform the housing benefit authority that you have made the following changes:  • Reduction of household members to be considered • Increase in qualifying income by more than 15% and • Reduction of the rent or charge to be taken into account by more than 15%.
Erforderliche Unterlagen	<ul> <li>The following is required to notify changes:</li> <li>Evidence of change in rent or encumbrance</li> <li>Proof of changed income</li> <li>Evidence of the change in the household members</li> </ul>

	to be taken into account.
	In individual cases, additional documents (e.g. additional income, proof of property, self-disclosure of a self-employed person, income forecast for the self-employed, proof of severe disability, etc.) may be required.
Voraussetzungen	The requirements for a change in housing benefit are:
	<ul> <li>the reduction or increase of the income to be taken into account by more than 15%</li> <li>the increase or decrease in the number of household members,</li> <li>the increase or decrease of the rent or charge to be taken into account in the case of residential property by more than 15%.</li> <li>These changes can, but do not have to, lead to an increase in housing benefit.</li> <li>For details, please contact your local housing benefit authority.</li> </ul>

Hinweise	In order to avoid or uncover the illegal claiming of housing benefit, the housing benefit authority may regularly check the household members by means of a so-called data comparison.
