This includes Preventive health care for the prevention and early detection of diseases Help with illness Help with family planning Help with pregnancy and motherhood Help with sterilization The assistance corresponds to the benefits of statutory health insurance, including the requirement for additional payments within the burden limit. If registration with a health insurance company is not possible, the social welfare provider will provide the necessary assistance by directly granting benefits within the framework of health assistance.

Verfahrensablauf	After you submit your application, the basic security and social welfare office will check and decide on your eligibility requirements.
Bearbeitungsdauer	A decision on the application will be made immediately. The processing time depends, among other things, on the completeness of the information and the submission of the evidence required to process the application.
Frist	The application should generally be made before treatment, and only immediately afterwards in the case of emergency treatment.
