Volltext	<p>If you want to live permanently in Germany, you should learn German and have knowledge of the history, culture and legal system of the Federal Republic. You will be supported by the integration course. You learn by taking part in an integration course to communicate independently in everyday life in German (level B1 of the GER Everyday knowledge about life in Germany and knowledge about our culture and recent history. The course basically consists of a language course of 600 teaching units (45 min each) to learn the German language and an orientation course of 100 teaching units (45 minutes each) to acquire everyday knowledge about life in Germany. Your ability to take part in an integration course depends on your residence status.</p> <p>COURSE TYPES Each integration course consists of a language course to learn the German language and an orientation course to acquire everyday knowledge about life in Germany and to acquire knowledge of the legal system, culture and history of our country. You must complete both parts of the course with one test each ("German test for immigrants" and test "Living in Germany"). Before you attend the integration course, there is a placement test. Based on the test results,</p>

you will be assigned to a specific course module. If applicable it is also recommended that you attend a special integration course. The following course types are available to you: General integration course The general integration course lasts a total of 700 teaching units (45 minutes each) and consists of 600 teaching units in the language course (6 sections and 100 teaching units in the orientation course. Special integration courses These courses are offered for Women Parents young adults who are no longer of school age and have not yet reached the age of 27 Immigrants who have acquired writing skills in one or more languages with a non-Latin writing system and are literate in these languages (duplicate learning course) Immigrants who cannot read or write or cannot read or write sufficiently (literacy course) and People who have been living in Germany for a long time and have only partially learned the German language (remedial courses) The special integration courses last 1,000 teaching units and consist of 900 teaching units in the language course (9 sections of 100 units each) and 100 teaching units in the orientation course. An exception to the special courses is the duplicate course with 600 teaching units in the language course and 100 units in the orientation course. The other exception is the intensive courses. The intensive courses are suitable for particularly fast learners and highly qualified participants. An intensive course lasts a total of 430 teaching units and consists of 400 teaching units in the language course and 30 teaching units in the orientation course. If you have properly attended the integration course (full hours of your individual quota if you attend regularly), the German If you have not successfully completed the test for immigrants, you have the option of contacting the regional office responsible for you at the Federal Office for Migration and refugees (see "WebGIS" under links) to submit an application for admission to repeat 300 teaching units. If you last attended the literacy or duplicate course, you must have used up your individual allotment of hours with regular attendance before submitting the application for admission to repeat, but you must not have completed the German test for immigrants. Please use one of the forms under Links for this purpose. Please note that when you apply

for admission to repeat 300 teaching units, you can also apply for exemption from the obligation to pay a fee. If you are allowed to repeat the course, the exemption from costs is not automatically given. The separate application form can be found under Links. COURSE SEARCH You can find suitable integration courses in your area using the information system of the Federal Office for Migration and Refugees WebGIS or via the portal KURSNET of the Federal Employment Agency. By entering your postal code or your place of residence, you can use it to research the contact details of facilities that you can reach. You can get personal help in finding a suitable integration course from the following places: Migration advice for adult immigrants and youth migration service foreigners Authority Employment agency, provider of basic security or corresponding institution of the municipality Provider of benefits according to AsylbLG integration course providers Federal Office for Migration and Refugees.

To register for an integration course, you need a certificate of eligibility, which the following authorities can issue: Immigration authorities (eligibility or obligation to participate) Basic security provider (participation obligation) Provider of benefits according to AsylbLG (obligation to participate) Federal Office for Migration and Refugees (admission, admission to repeat) Federal Office of Administration (confirmation of entitlement for late resettlers)

PARTICIPATION POSSIBILITIES / COURSE TYPES / COURSE SEARCH As a non-EU citizen (third-country national) you are entitled to attend an integration course, if you received a residence permit for the first time after January 1, 2005 and are staying permanently in Germany as an employee (§§ 18, 21 AufenthG), for reasons of family reunification (§§ 28, 29, 30, 32, 36 AufenthG); as a long-term resident (§ 38a AufenthG), if you received a residence or settlement permit for international law, humanitarian or political reasons after January 1st, 2005 and you are staying permanently in Germany by order of the Federal Ministry of the Interior to protect special political interests (§ 23 Para. 2 AufenthG) or by order of the

Federal Ministry of the Interior for the resettlement of people seeking protection (resettlement refugees, § 23 Para. 4 AufenthG) or upon recognition as a person entitled to asylum (§ 25 Para. 1 AufenthG) or if refugee status or subsidiary protection is granted (section 25 subs. 2 of the Residence Act) or as a victim of a criminal offense under Sections 232, 233 or 233a of the Criminal Code after the criminal proceedings have ended, if humanitarian or personal reasons or public interests require continued presence in Germany (Section 25 (4a) sentence 3 of the Residence Act) or in the case of sustainable integration of those who have been tolerated (§ 25b AufenthG). Furthermore, late resettlers and their spouses or descendants are entitled to free participation in an integration course (§ 9 Para. 1 BVFG). The corresponding confirmation is issued by the Federal Office of Administration. You are not entitled to participate in the integration course if you are a child, adolescent or young adult and you are starting school or continuing your previous school career in the Federal Republic of Germany, you have a recognizable low need for integration or if you already have sufficient knowledge of the German language (level B1 of the CEFR). In the latter case, however, you have the opportunity to take part in the orientation course. Under certain circumstances, an authority can also oblige you to participate. Such a participation obligation is considered: by the immigration authorities: if you are entitled to participate and cannot communicate at least in a basic way in German (level A1 of the GER) (§ 44a Para. 1 S. 1 No. 1 lit. a) or do not have sufficient knowledge of the German language (level B1 of the GER) at the time the residence title is issued in accordance with Section 23 (2), Section 28 (1) sentence 1 no. 1 or Section 30 AufenthG (Section 44a (1) sentence 1 No. 1 lit. b).

To take part in an integration course, you need a valid certificate of entitlement, which the following authorities can issue to you, depending on your residence status: Immigration authorities (eligibility or obligation to participate) Basic security provider (participation obligation) Provider of benefits according

to AsylbLG (obligation to participate) Federal Office for Migration and Refugees (admission, admission to repeat) Federal Office of Administration (confirmation of entitlement for late resettlers). After receiving the certificate of eligibility to take part in an integration course, register with a course provider in your area as soon as possible (see WebGIS). If the entitlement certificate has a validity date, you must register by Register with a course provider when the validity expires. A registration after expiration validity is no longer possible. If you have been obliged to take part in the integration course, you must register immediately and submit proof of this to the obligatory authority (foreigners authority, provider of basic security or provider of benefits under AsylbLG). Information on course providers and course offerings can be found in the information system of the Federal Office for Migration and Refugees.

Frist

After receiving the certificate of eligibility to participate in an integration course Contact a course provider near you as soon as possible (see WebGIS). If the certificate of eligibility has a validity date, you must register with a course provider before the validity expires. Registration after the validity has expired is no longer possible. If you have been obliged to take part in the integration course, you must register immediately and submit proof of this to the obligatory authority (foreigners authority, provider of basic security or provider of benefits under the AsylbLG).

Hinweise

The immigration authorities can also oblige you to attend a course when issuing a residence permit in accordance with Section 25 (1) or (2) of the Residence Act (person entitled to asylum, recognition of refugee status or subsidiary protection) if you are only able to communicate in a simple manner in German (level A1 of the GER) be able to communicate. In addition, you are obliged to take part in the integration course if you

have a special need for integration and the immigration authorities ask you to take part (Section 44a (1) sentence 1 no. 3 of the Residence Act). A special need for integration can be assumed in particular if you, as the person responsible for caring for a minor living in Germany, do not have sufficient knowledge of the German language (level B1 of the GER) and you have therefore not yet been able to establish yourself integrate into the economic, cultural and social life of the Federal Republic of Germany without state aid. by the provider of basic security: If you receive unemployment benefit II and participation in the integration course is provided for in the integration agreement according to SGB II (Section 44a, Paragraph 1, Sentence 1, No. 2 of the Residence Act). by the provider of benefits under the Asylum Seekers Benefits Act (§ 44a Para. 1 S. 1 No. 4 AufenthG): If you receive benefits under the Asylum Seekers Benefits Act and as an asylum seeker have a residence permit according to § 55 Para. 1 AsylbLG and a lawful permanent residence can be expected with you (good prospects of residence, which are currently given in the following countries of origin: Eritrea, Iraq, Iran, Somalia and Syria) and the Federal Republic of Germany for the is responsible for carrying out your asylum procedure or have a toleration according to § 60a Abs. 2 S. 3 AufenthG or hold a residence permit in accordance with Section 25, Paragraph 5 of the Residence Act. You are exempt from the obligation to participate if you are in Germany in vocational or other training, You can provide evidence of participation in comparable educational opportunities in Germany (e.g. public or private schools, vocational schools or private courses offered by employers or other providers) or Your participation is impossible or unreasonable in the long term (e.g. if you have a disability or are caring for disabled family members). You can be admitted to an integration course by the Federal Office for Migration and Refugees within the limits of available course places, if you are a German citizen, do not have sufficient knowledge of the German language (level B1 of the GER) and have not yet been able to integrate into the economic, cultural and social life in the federal territory without state help (§ 44 Para. 4 S. 2 alternative 1 AufenthG in conjunction with Section 5 (4) No. 4 IntV),

if you are an EU citizen entitled to freedom of movement or your family members do not have sufficient language skills (level B1 of the GER) and you have not yet been able to integrate into the economic, cultural and social life in the federal territory without state help (§ 11 Para. 1 S 1 FreizügG/EU in conjunction with Section 44 (4) Residence Act and Section 5 (4) No. 4 IntV), if you are a non-EU citizen and obtained your residence permit before January 1, 2005 (Section 44 (4) sentence 1 of the Residence Act), if you are a non-EU citizen who had a legal right to attend an integration course but were prevented from attending for reasons beyond your control, if you are a non-EU citizen and as an asylum seeker have a residence permit according to Section 55 (1) AsylG and a lawful permanent residence can be expected with you (good prospects of staying, which are currently given in the following countries of origin: Eritrea, Iraq, Iran, Somalia and Syria) and the Federal Republic of Germany for the is responsible for carrying out your asylum procedure or have a toleration according to § 60a Abs. 2 S. 3 AufenthG or hold a residence permit in accordance with Section 25, Paragraph 5 of the Residence Act.
