Volltext	Help in other life situations can be granted to you for the following: Lunch in the workshop for disabled people Travel costs for exercising visitation rights Body-related care and support measures for persons below care level 2 and who have not yet reached the normal retirement age. Decisions may be made on a case-by-case basis if the life situation giving rise to the need is not regulated in Section 8 of the Social Code Book XII or in other areas of social law.

Verfahrensablauf	After you have submitted your application, the basic security and social welfare office will check and decide on the eligibility requirements.
