Teaser	The marriage certificate is issued if it is required for marriage abroad.

Modul	Sachverhalt
Volltext	<p>If you want to marry abroad, it may be that there is a legal standard in the intended marriage state that requires the submission of such a certificate. The authority for issuing a marriage certificate for German citizens with domicile or habitual abode abroad lies with registry office 1 in Berlin.</p>
Erforderliche Unterlagen	<p>The requirements, type and format of the evidence to be provided and the examination of the marriage requirements are based on German law as with a German citizen.</p> <p>The following must be proven by means of public documents:</p> <ul style="list-style-type: none"> • The marital status • Residence, habitual abode • Nationality • The birth • As well as, if applicable, the last marriage and/or civil partnership and their dissolution • Possible name changes
Voraussetzungen	<ul style="list-style-type: none"> • You must have German citizenship. • You must be domiciled and habitually resident abroad • The intended marriage is to take place abroad • According to German law, no impediment to marriage may stand in the way of the intended marriage
Kosten	<p>There may be costs for the issuance of a marriage certificate. Please contact registry office 1 in Berlin.</p>
Verfahrensablauf	<ul style="list-style-type: none"> • You apply for the issuance of a marriage certificate at registry office 1 in Berlin. • If the examination shows that there are no obstacles to the marriage under German law and if the required personal information has been provided for both spouses, the registry office 1 in Berlin will issue the requested certificate of marriageability.
Bearbeitungsdauer	<p>The processing time depends on the individual case.</p>
Frist	<p>Once issued, the marriage certificate is valid for a period of six months.</p>
