Volltext	<p>After you have successfully completed your state examination as a geriatric nurse, you need a professional license in the form of a professional certificate in order to be allowed to work in this profession.</p> <p>Nursing training in Germany was reformed on January 1, 2020 and the new Nursing Professions Act applies. The profession based on this is called "nursing specialist" or "nursing specialist" and is new. There is a transitional period for the professional license based on the Nursing Act. Until December 31, 2024, temporary work permits may still be granted as a geriatric nurse. The competent authority will advise you.</p>
