The cooperative register is a so-called public register and provides information about the facts and legal relationships of the legal entities registered here. The entry on the register sheet contains Information about the name, Object, Board of Directors including its representation regulations, any power of attorney as well as the obligation to make additional contributions and changes to the statutes of the respective cooperatives. In addition, the documents submitted by the cooperatives to the cooperative register, such as the statute (articles of association) or minutes of general meetings, can be inspected. |

| Kosten | Information can be obtained free of charge online in the register portal of the federal states. A certified copy is subject to a fee. |
| Verfahrensablauf | The joint register portal of the federal states is available to you on the internet to inspect the register of cooperatives. There you have the option of searching for registered cooperatives by entering keywords, calling up detailed information and also receiving the contents of the register as a PDF document. In addition, you can continue to view the register of cooperatives during business hours at the responsible register court and, if necessary, receive a |
