Teaser	As a recognized injured person, you will receive treatment for recognized damage consequences upon application.
Volltext	As an injured person, you are entitled to treatment for recognized health disorders. If you are severely disabled, benefits will also be granted for conditions that are not covered; under the same conditions, the family members and caregivers of the severely disabled and all surviving dependents can claim medical treatment. The type and scope of the services generally correspond to those of statutory health insurance. The treatment includes outpatient medical and dental treatment, supply of medicines and bandages, Supply of remedies including physiotherapy, movement therapy, speech therapy and occupational therapy provision of dentures, treatment in a hospital, treatment in a rehabilitation facility, Home care, supply of aids, stress testing and occupational therapy, non-medical social pediatric services, Psychotherapy as

Erforderliche Unterlagen	Application (informal possible) Notification of recognition according to the social compensation law
Voraussetzungen	Health disorders recognized as the result of damage or caused by a recognized consequence of damage (causality)
Kosten	If only the consequences of damage are treated within the usual framework, no co-payments or deductibles may be charged.
Verfahrensablauf	Health and medical treatment services are generally provided upon application. The following benefits are provided directly by the responsible pension office and can be applied for there: dentures aids exercise therapy speech therapy occupational therapy stress testing occupational therapy spa treatments, replacement services, disabled physical exercises All other services are provided by the health insurance company for the care administration. If a beneficiary is not a member of a health insurance company, they should contact the responsible pension administration.
Bearbeitungsdauer	The treatment is usually provided immediately. Certain services (e.g. orthopedic care, dentures) must be checked in an approval process and should therefore be applied for in good time.
Frist	Services are only provided upon request.
