Teaser	Are you running a business as a legal entity and have appointed someone else to represent you? You must inform the responsible authority immediately.
Volltext	You can view the authorized representatives of a company in the commercial register. You can view this information free of charge on the commercial register website and also access commercial register extracts from this website. Changes in authorized representatives must be registered electronically with the commercial register via a notary. You can also request extracts from the commercial register in writing from the Hamburg District Court, Commercial Register, stating the registration number.

Verfahrensablauf	You must inform the authority to which you have registered your business that there has been a change in the authority to represent you. To do so, use the prescribed notification form and attach the required documents. Commercial register entries can be made online on the website of the commercial register. Changes to authorized representatives must be registered electronically in notarized form with the commercial register.
