Teaser	If you want to build or operate a filling station for flammable liquids with a flash point <23°C or make certain changes to the design or operation that affect the safety of the facility, you must apply for a permit.
Volltext	Gas stations are stationary facilities that refuel land, water and aircraft vehicles with flammable liquids (flash point <23°C). They are systems that require monitoring. You need permission from the relevant authority if you:  • want to build and operate a gas station • want to make changes to the design or operating method that affect the safety of the system

## **Sachverhalt**

Permission may be granted to you subject to the following restrictions:

- limited
- limited
- under conditions
- with conditions

If the facility requiring a permit is part of a facility requiring a permit, no separate permit will be issued. Approval includes permission.

## Erforderliche Unterlagen

Informal application with the following information:

- · Last name, first name, company name
- Applicant's address

Documents to be able to assess the system:

- Subject of the application
- Description of the facility
- Description of the system technology and interaction with other systems, for example washing systems
- Piping and instrument flow diagram (P&ID flow diagram)
  - Safety data sheets
- Description of operation
- Permanently occupied position when operating without supervision
- Overview plan
- Site plan
- Floor plan or technical plan
- Ex zone plan
- Explosion protection concept
- Fire protection information
- Description liquid-tight roadway with drainage and effective areas
- Calculation of manufacturing costs
- Other facilities
- Test report from an approved monitoring body

	(ZÜS). The test report must confirm that the system can be operated safely if the measures mentioned are adhered to.
Voraussetzungen	<ul> <li>The system for which you are applying for permission must be a system that requires permission.</li> <li>You must build and operate a gas station using state-of-the-art technology.</li> <li>Your documents must be complete, plausible and meaningful.</li> <li>The test report from the approved monitoring body (ZÜS) must confirm that the system applied for can be operated safely if the measures specified in the documents, including the tests, are adhered to.</li> </ul>
Kosten	Fees are charged for processing the permit application in accordance with the fee schedule for the areas of occupational safety and plant and product safety (ArbSchGebO HA).  The amount of the fee depends on the time required to examine the application documents and prepare the permit.
Verfahrensablauf	<ul> <li>Submit the application for approval of the system requiring monitoring with the necessary documents, including the test report from the approved monitoring body (ZÜS), to the responsible authority.</li> <li>If there is a requirement for approval under the Federal Immission Control Act, you will receive the application documents back, as a permit under the Industrial Safety Ordinance will then be checked as part of the necessary approval under the Federal Immission Control Act.</li> <li>The responsible authority will make its decision after review and communicate it to you.</li> </ul>
Bearbeitungsdauer	The competent authority must decide on the application within three months of receiving it.
Frist	A permit that has been granted expires if: • you have not started constructing the system within two years after the permit was granted, • you have interrupted the construction of the system for two years or longer, or • You have not operated the system for a period of three years. You can apply to the licensing authority for an extension of the deadline for important reasons.

Rechtsbehelf	<ul> <li>You can object to the decision within one month of the announcement.</li> <li>You must submit the objection to the responsible authority in writing or for recording.</li> </ul>
Kurztext	<ul> <li>Construction and operation of a system requiring monitoring in accordance with the Industrial Safety Ordinance, permission from gas stations</li> <li>Anyone who wants to build or operate a gas station or make changes to their design or operation requires a permit.</li> <li>Gas stations are "facilities requiring monitoring" within the meaning of the Industrial Safety Ordinance.</li> <li>They must be assembled, installed and operated according to the state of the art.</li> <li>Permission can be granted:</li> <li>under conditions</li> <li>limited</li> <li>limited</li> <li>limited</li> <li>associated with conditions</li> </ul> Application: <ul> <li>You can submit the application informally in writing or electronically.</li> <li>An application for partial permission is possible.</li> <li>The Office for Consumer Protection is responsible</li> </ul>
