Teaser	You have applied for guardianship for your child and no longer need it? Then you can end the guardianship.
Volltext	The parent who applied for guardianship can terminate it at any time. All that is required is a written declaration to the competent authority or the use of the relevant online service[A1] . The guardianship ends automatically when the legal requirements are no longer met. This is the case, for example, if: • the child is of legal age, • the single parent and the child move abroad (residence abroad), • the guardianship has fulfilled its purpose, for example paternity has been established.

Verfahrensablauf	An informal written notification is sufficient. All parties involved will be notified in writing, and depending on how the case progresses, a final invoice will be issued and the parent applying may receive

Bearbeitungsdauer	The assistance ends as soon as you inform the youth welfare office in writing. Written notification may take 2-3 weeks, depending on the scope of the case.
