Volltext	For the commercial transport of people with a rental car you need a license. When you determine the number of vehicles for your rental car business If you want to increase it, you must request an extension from the relevant transport authority apply for permission.
Erforderliche Unterlagen	Valid authorization Application for an extension of the rental car permit (surname, first name of the applicant; place of residence and place of business; for natural persons, birthday, place of birth; number of vehicles, vehicle type, capacity of the vehicles to be used) Certificate of equity / additional certificate (form in accordance with Section 2 Paragraph 2 No. 2/Section 2 Paragraph 3 of the Occupational Access Ordinance for Road Passenger Transport - PBZugV), not older than 3 months Certificate of clearance from the tax office, the municipality, the social insurance provider and the professional association, not older than 3 months (from the company, the legal representative and the person/traffic manager appointed to manage the business) Certificate of good conduct to be presented to the authorities in accordance with Section 30 Paragraph 5 BZRG Extract from the central commercial register in accordance with Section 150 Paragraph 5

	<p>GewO (for companies) Extract from the fitness to drive register (FAER) General documents: Vehicle list, possibly rental vehicles with rental agreement or leasing list Proof of liability insurance for rental cars including risk code (WKZ) Proof of the installation of an alarm system or exemption in accordance with Section 25 BOKraft Proof of the installation of an odometer Business registration, if not already available to the authorities</p>
Voraussetzungen	<p>As an entrepreneur, the applicant already has a rental car permit. The safety and performance of the company are guaranteed. There are no facts to suggest that the person applying as an entrepreneur or the person appointed to manage the business is unreliable. The applicant as an entrepreneur or the person appointed to manage the business is professionally qualified. The applicant and the entrepreneurs commissioned by him or her to provide transport services have their place of business or branch within the meaning of commercial law in Germany. For legal entities under public law, the requirements are considered to be met.</p>
Kosten	<p>The amount of the fees depends on: the number of vehicles and the term of the approval.</p>
Verfahrensablauf	<p>Follow these steps to extend your commercial license To obtain transportation for people with multiple rental cars: •Submit a corresponding application to the transport authority responsible for you and attach all necessary documents to the application. The authority processes your application and carries out the necessary hearing procedures. You will receive a notification about the decision to extend your rental car permit. If necessary, you will receive the approval certificate(s).</p>
Bearbeitungsdauer	<p>The processing time can vary between the responsible transport authorities vary. The processing time can depend, among other things, on whether everyone documents relevant to the decision were presented, or whether Subsequent requests for documents become necessary.</p>
Frist	<p>Deadlines only begin to run when an application ready</p>
