Teaser	If you, as a shooting club, already have a firearm ownership card (WBK) and want to purchase another firearm that requires a permit, you must apply for this.
Volltext	If your shooting club already has a gun ownership card and you want to purchase additional firearms for the club that require a permit in addition to the weapons registered there, you will need a permit to do so. The permit is issued by the responsible authority by making an entry in the gun ownership card (pre-entry).
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• Identity card or passport (copy)</li> <li>• Weapon ownership card (WBK) for clubs</li> </ul>

	<ul style="list-style-type: none"> <li>• Proof of safe storage</li> </ul>
Voraussetzungen	<ul style="list-style-type: none"> <li>• You have a firearms license (WBK) for clubs.</li> <li>• You must prove that you can safely store the weapon you wish to purchase.</li> </ul>
Kosten	There is an administration fee. The amount of the fee depends on the type and scope of your application.
Verfahrensablauf	<ul style="list-style-type: none"> <li>• You submit your application together with the necessary documents.</li> <li>• The responsible authority will examine your application and, if necessary, request any missing documents from you.</li> <li>• The decision of the competent authority will be communicated to you.</li> </ul>
Bearbeitungsdauer	Up to several weeks
Frist	With the pre-registration you have one year to purchase the registered weapon that requires a permit.

Hinweise	<p>In the application for a permit to continue purchasing a firearm, you only need to state what type of weapon and what caliber you want to purchase. Further information, such as the manufacturer and exact model, is not required at first. You only need to provide this information once you have purchased the weapon and have fulfilled your obligation to report the purchase of the weapon to the relevant authority. The gun dealer must also report the transfer of the weapon to you.</p> <p>To make it easier to fill out the declaration, you can use the National Weapons Register identification numbers (NWR-ID):</p> <ul style="list-style-type: none"> <li>• Use your personal NWR ID (for example P- or F-NWR-ID) for personal information.</li> <li>• Use the permit NWR ID (E-NWR ID) for information on firearms permits.</li> <li>• The weapon or weapon part NWR ID (e.g. W- or</li> </ul>
